We will provide a nonthreatening and nurturing environment for our students to

learn in school and model/sustain at home.

The administrators of Wadsworth Elementary School, along with the Title 1 Advisory Council, are responsible for the planning, review, and improvement of the school-based Title 1 program. We will invite all parents to join the Title 1 Advisory Council throughout the school year. We will first recruit for membership during our school SAC and PTO Meeting, held during the start of the new school year.

The Title 1 Advisory Council will meet throughout the year, on the same dates as the Parent-Teacher Organization and the School Advisory Council, to gather input from, and involve, parents in the development of the required plans. Parental input will be documented through meeting minutes, agendas and sign-in sheets. To encourage greater parent participation, Title I Advisory Council meetings will be scheduled to best meet the needs of the parents (SAC & TAC.)

Childcare will be provided for families.

Specific examples of the flexible schedules offered to parents are morning meetings before school starts, evening meetings after dinner, meetings during the dinner hour with food provided, and going into the community during the weekend.

Podcasts and home visits will be provided to parents who want to be involved with their child's educational program. We also send a Skylert reminder to parents 1-3 days in advance to remind them of the meeting. School website will be used to include items such as: parent involvement link, Pod-casts, Student Planners, Title I newsletters, Call Messenger System, School and Classroom Teacher Newsletters, Open House, Student/Parent workshops, Teacher-Parents Response to Intervention meetings, and Parent-Teacher conferences.

Documentation will be tracked in the school-based "Parent Involvement" notebook.

We have a group of parents who speak different languages. We will send home communications to these parents in their home language and have interpreters to assist them at meetings, so they can be involved, to the best of our ability.

The massive array of activities you will find at WES involves families and parents in their child's education. We host multiple McDonald's Nights in town, movie nights, PRIDE nights, open houses, etc. These are evenings where students can bring in their parent to not only showcase the hard work and success of the learner, but involve their family in the process by giving the student a voice to share the educational process, wherein the learner may deepen their knowledge by teaching it to their parent.

In the Fall, the Media Specialist, Principal, and Assistant Principal have an introduction and tour of the parent resource center which is built into the SAC, PTO and Title I Advisory Council meetings as well as during school orientation. Success is determined by verbal comments of attendees and documented by sign-in sheets.

In October, the Principal, Assistant Principal, teachers, and support staff have a Fall Festival called the (Boo Bash). Students and parents attend a fall festival that includes educational and non educational games and activities. Success is determined by verbal comments of attendees and numbers of attendees.

Call Messenger System (Skylerts) will be used before each event and to make important announcements. School and Classroom Teacher Newsletters go home to families weekly or monthly. Open House Orientation (August and September), Student/Parent workshops (September, November, March), Teacher-Parents Response to Intervention meetings (ongoing), and Parent-Teacher conferences (twice per year). Documentation will be tracked in the school-based "Parent Involvement" notebook via Angela Hannant.
